

Repair and maintenance of your home

As a landlord, there are lots of repairs in the homes we own that we are responsible for. It is important that you, as our tenant, also know which repairs you will have to do yourself.

We are responsible for all repairs to your home's structure, gas, plumbing, electrics and any other area where it is identified as a hazard or a risk to health and safety, however you may have to pay the costs when a repair is necessary if it is due to your neglect, negligence or wilful damage. As a the tenant, you will be responsible for decorating your home and replace fittings, like batteries in heating controls, light bulbs and internal doors.

We will carry out non-standard repairs if you request them, for example something not covered in this guide. However, you will be charge for the cost of the work, we will tell you how much this will be before we make a non-standard repair. We must make gas and electricitical non-standard repairs to meet health and safety legislation, but you will still need to pay the costs of this work.

This guide shows who is responsible for which type repair and are represented in the pictures with the following:

These repairs are your responsibility, they are maked in yellow:



These repairs are our (Vico Home's) responsibility, they are marked in green:



The responsibilty for these repairs are shared by you and ourselves, this may depend on the type and the reasons for the repair. They are marked in purple:







Some repairs meintion 'fair wear and tear'. This means something that has worn out over time from normal use.






If you did not get our permission and installed a driveway we may remove it and charge you the cost.


If you share a driveway with other people and we need to make repairs becasue it is dangourous or a health and safety risk, we may charge you for part or all of the costs.


